Internal viewing of this spacious and extremely well presented Victorian terrace house is strongly recommended. The gas centrally heated and uPVC double glazed accommodation retains many character features including cast iron fireplaces, stripped floorboards and also most stripped pine internal doors remain. To the outside there is a smart block pavier courtyard garden with recently erected feather board fencing together with a useful rear pedestrian access. Eastbourne Gate is a no through road on the edge of the town centre. The facilities of the town centre are approximately three quarters of a mile distant.

Pantry cupboard, single drainer stainless steel sink unit with mixer tap, plumbing for washing machine, gas cooker point, radiator.


Landing Access via pull down ladder to insulated and boarded roof space also housing the gas fired combination boiler which supplies centralk heating and hot water (installed 2011). Linen cupboard.

Bedroom One 12' 1" x 14' 1" (3.68m x 4.29m) Original stripped door, picture rail, cast iron fireplace, radiator.

Bedroom Two 11' 2" x 8' 6" (3.4m x 2.59m) Cast iron fireplace, picture rail. radiator.

Bathroom Attractively fitted with a white suite comprising a double ender bath with central taps, low level wc, pedestal wash hand basin and a separate shower cubicle with Mira thermostatically controlled shower, coloured glass tiled splashbacks, chrome ladder radiator and radiator.


