The ground floor boasts three generous reception rooms, a well-proportioned kitchen/breakfast room, and a conservatory. Occupying an elevated and private plot, the property is surrounded by mature, well-established gardens to both the front and rear. The property is accessed via a storm porch at the front, leading into a spacious entrance hallway. From here, you'll find three principal reception rooms, each featuring exposed floorboards that add character and warmth. The large kitchen/breakfast room includes a log burner and doors opening out to the rear garden. The third reception room flows seamlessly into the conservatory, significantly enhancing the sense of space and light throughout the ground floor. Upstairs, the first floor offers two bedrooms and a family bathroom. Externally, the property enjoys a beautifully maintained front garden with a lawn and mature trees, while the private rear garden features established planting, trees, and patio areas. Additional benefits include driveway parking to the side and a garage.

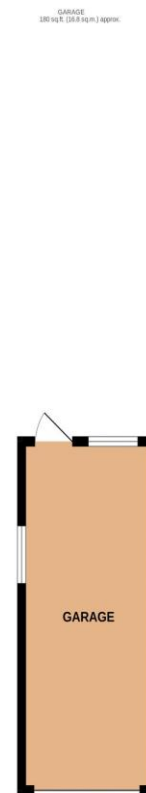
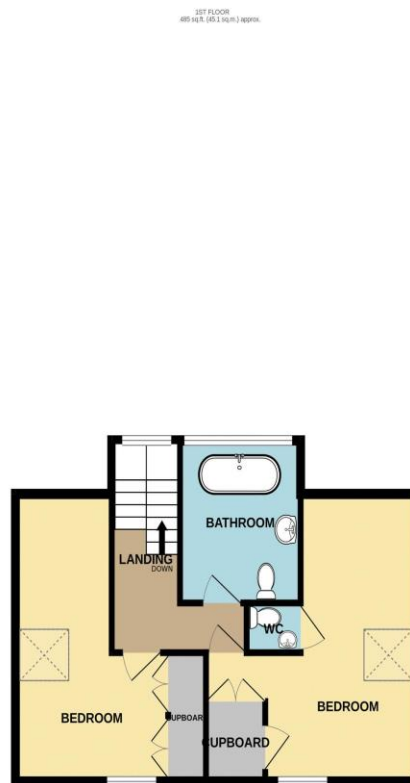
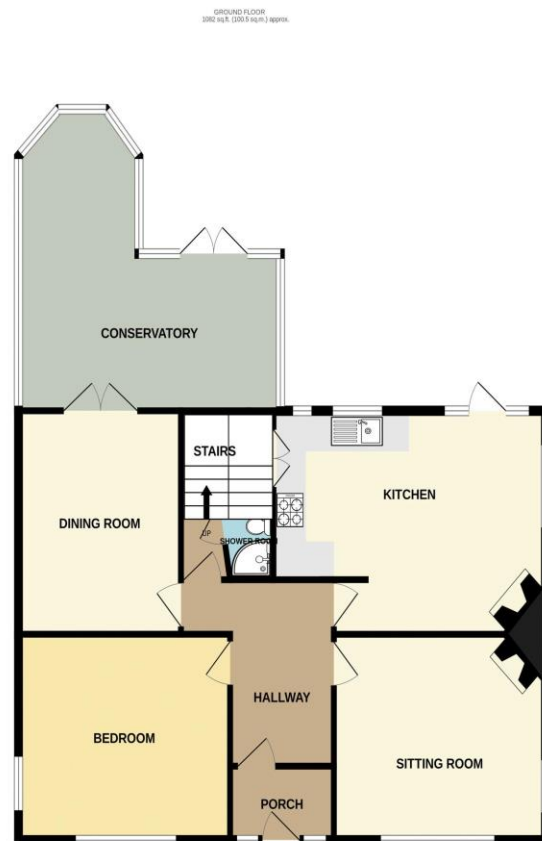
