This unique three bedroom detached family home is beautifully presented from top to bottom and situated within easy access to the town centre. The spacious well proportioned accommodation comprises in brief; entrance hall, lounge, large kitchen/dining room, ground floor WC. To the first floor a landing leads to three good size bedrooms (master with en-suite shower room) and family bathroom.

The property is fully UPVC double glazed and warmed by mains gas fired central heating and benefits from modern stylish kitchen and sanitary fittings throughout. Externally, the property has multiple off road parking and gardens to the front, side and rear. The town of Bridgwater lies within easy walking distance and offers an excellent range of shopping, leisure and financial amenities. Access to the M5 motorway can be gained at Junction 24 which is located within one mile of the property. Bridgwater town itself also offers a mainline intercity railway station.

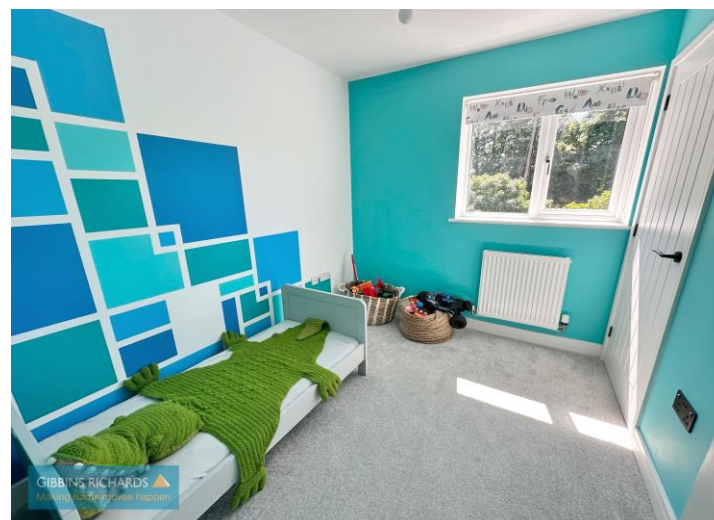
Entrance Hall	12' 6" x 7' 8" (3.81m x 2.34m) Stairs to first floor with understairs storage cupboard.
Cloakroom	6' 4" x 2' 9" (1.93m x 0.84m) Side aspect obscure window. Low level WC and wash hand basin.
Lounge	13' 3" x 12' 6" (4.04m x 3.81m) Front aspect window.
Kitchen/Diner	19' 11" x 10' 6" (6.07m x 3.20m) Rear aspect window and French doors to garden. Fitted with a modern stylish range of matching eye and low level units. Integrated washing machine, dishwasher, electric oven with four ring hob over, extractor fan and light over. Space for 'American' style fridge/freezer.
First Floor Landing	Side aspect window. Doors to three bedrooms and bathroom. Airing cupboard housing 'Glowworm' gas combination boiler. Hatch to loft.
Bedroom 1	11' 6" x 11' 2" (3.50m x 3.40m) Rear aspect window. Door to;
En-Suite Shower Room	7' 7" x 4' 3" (2.31m x 1.29m) (into shower). Rear aspect obscure window. Low level WC, wash hand basin and enclosed shower cubicle. Heated towel rail.
Bedroom 2	12' 1" x 8' 10" (3.68m x 2.69m) (excluding walkway) Front aspect window.
Bedroom 3	8' 6" x 7' 6" (2.59m x 2.28m) Front aspect window. Cupboard over stairs recess.
Bathroom	7' 7" x 5' 1" (2.31m x 1.55m) Rear aspect obscure window. Low level WC, wash hand basin and bath with shower attachment. Heated towel rail.

Outside

Situated immediately to the side of the property is a driveway providing off road parking. The property is well screened from Taunton Road by stone wall and hedge row. The rear garden measures approximately - 39' (11.88m) in width by 21' (6.40m) in depth. There is a paved patio area adjoining the property providing pleasant seating space with steps leading to a raised area of lawn with raised borders. Situated to the far side is a further area of lawn fully enclosed by stone and timber/wire fencing. Outside lighting, tap and weather proof socket. Pedestrian gate leads to front/side parking area.



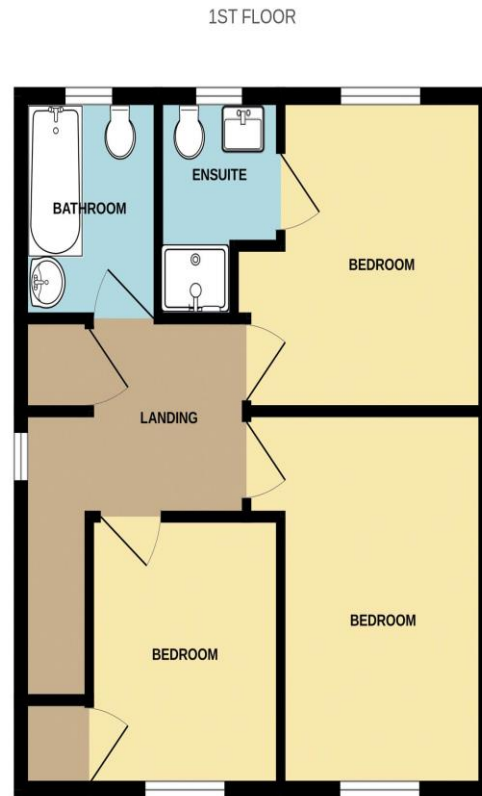
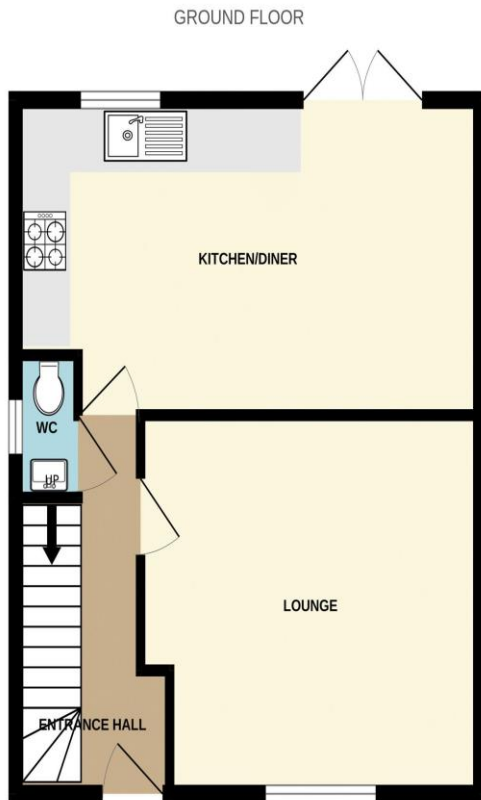
